

## Directions to the Simpsonville Activity & Senior Center

From Spartanburg: Take I-85 South to I-385 toward Columbia. Take Exit 31 (Simpsonville...Do not take the toll road). Turn left at light onto NE Main Street. Go 3 miles. Turn right at the Clock Tower onto West Curtis Street. Go ¼ mile. Activity Center is on the right.

From Atlanta: Take I-85 North to I-385 toward Columbia. Take Exit 31 (Simpsonville...Do not take the toll road). Turn left at light onto NE Main Street. Go 3 miles. Turn right at the Clock Tower onto West Curtis Street. Go ¼ mile. Activity Center is on the right.

From Columbia: Take I-26 to I-385 toward Greenville. Take Exit 27. Go straight at the light. Go approximately 2 miles to second stop sign. Take a left at the stop sign onto West Curtis Street. Activity Center is on the right.

**ENTRY DEADLINE:** There is no entry deadline. Applications are accepted/rejected as they are received as long as there is still space in the show. A waiting list will be compiled once the show has been filled, and will be contacted as soon as possible if spaces open up.

**WHAT ITEMS ARE ELIGIBLE:** Hand craft items, embellished items, local businesses.

**FEES AND CHARGES:** Upon acceptance into the show, FEES ARE NON-REFUNDABLE.

**NOTE:** All table and chair reservations must be made in advance on this application. There will be no additional tables/chairs available on show day.

**EXHIBITOR SET UP:** Exhibitors will be able to set up their booth on FRIDAY, NOVEMBER 20<sup>th</sup> from 3:00p.m. until 8:00p.m in the main Gym. If you are a later applicant that is assigned to the smaller gym, set up will be from 7:30a.m.-8:45 a.m. on November 21<sup>st</sup>. Applications will be assigned on a first come first served basis, so please apply early. Doors will be open to all vendors at 7:30 a.m. Saturday, November 21.
